The Friends are established to advance the restoration, preservation, repair, maintenance, improvement and beautification of the Grade 1 Listed Building, the Parish Church of St Mildred, Tenterden in the Diocese of Canterbury and of the monuments, fittings, fixtures, stained glass, furniture, ornaments and chattels in the church and churchyard belonging to the Church.

Arrange and provide for or join in arranging and providing for the holding of exhibitions, meetings, lectures and classes and concerts and recitals and events

Raise funds by any lawful means and through any lawful activity and invite and receive contributions from any person or persons whatsoever by way of subscriptions.

Collect and disseminate information on all matters affecting the objects. Summary of the main achievements of the charity during the year

This has been another successful year for the Friends of St Mildred's Church. But the year has also been touched by sadness, as a few loyal Friends have sadly passed away. Of particular significance to the world of FOSM was the death of Peter Sienesi, the founder and inspiration behind FOSM when it was first established in 2014. Peter was our first Chairman from 2014-17, but he continued to support us generously in inestimable ways thereafter behind the scenes. He was always proud of what FOSM had achieved, and rightly so. We miss him very much. The other loss of particular significance to FOSM was the sudden and unexpected death of Committee Member Tony Pearlman, a charming and resourceful member of our team with particular front of house skills that proved invaluable at FOSM events. Our condolences we send once more to the family and friends of Peter and Tony.

On a happier note, I can report that we now have a strong and enterprising Committee of 10 members whose collective skills and experience are proving extremely valuable to the running of the charity. But we are always on the lookout to welcome new Committee members including from November 2024 a new Chairman when I reach the point of statutory retirement.

FOSM finances are in good shape as is apparent from the report of the Honorary Treasurer. We have taken the decision to place some of our reserves in a fixed term interest bearing account with the Charity Bank, to take advantage of the current high interest rates. This will not affect our ability to respond in a timely fashion to requests for further funding from the PCC, as and when they arrive.

To this end we have recently presented the PCC with a cheque for £22,500 as a grant towards the repair and maintenance of the North Aisle Roof. We hope to be in a similar position to assist in the same process for the South Aisle Roof when the PCC are ready to proceed.

We continue to raise funds from 3 separate sources, each of which accounts for about one third of our annual income: Friends' subscriptions, donations (including legacies), and events. As a consequence, I am pleased to report that we are well on target to reach our goal of having raised since 2014 a total of £200,000 towards the repair and maintenance of St Mildred's Church, by the end of 2024.

Our events programme over the past year has been a great success, with a series of very high quality concerts provided by musicians both from the world of jazz and classical music. We organized 2 great cabaret style evenings of jazz complete with candlelit tables and pay bar. We were hugely entertained by old favourites, the Kate Daniels Sextet and the Benoit Viellefon Hot Club Jazz Band. Both events filled the church with music that was joyful, moving, emotional and fun in a variety of different ways. To balance this we welcomed back our Artists in Residence - the Bukolika Piano Trio - for their final concert, followed by a recital from the wonderful young Lithuanian pianist of prodigious talent, Ignas Macknikas, this event being sponsored by the Countess of Munster Musical Trust.
